Overview

The LifeCourse team has published ten articles in top research journals, published nine conference abstracts, and has six additional papers under review. Research findings have been presented at more than 40 conferences and annual research meetings across the country hosted by organizations such as AcademyHealth, Gerontological Society of America, and American Academy of Hospice and Palliative Medicine. Our team also presents work throughout Minnesota at conferences hosted by the University of Minnesota and Minnesota Network of Hospice & Palliative Care. Additionally, our research findings have appeared in five webinars, and received press coverage in three media outlets. LifeCourse has also been featured in online MinnPost articles, the *Minnesota Physician*, and a series of documentaries that have aired multiple times on Twin Cities Public Television.
